Legal Issues Update

Mr. Cameron updated the Board on active legal issues. The Management (IBEW) Union has an arbitration scheduled for the fall of this year that is related to pay increases for an employee hired in 2007. The Clerical Technical Unit has an arbitration scheduled for June 17. The RMLD, along with three other municipal utilities are taking legal action against the ISO-NE for the use funds in lobbying activities.

Power Supply Update

Ms. Parenteau gave the Board an update on the recent activities related to power supply. The RMLD is having ongoing conversations with the developers of the Concord Steam Unit, a wood fired generator located in Concord, NH. The Berkshire Power Developer has remained in touch with the RMLD, however, they are dealing with permitting issues and the interest level is low. The developers of the Tamarack wood fired unit located in western Massachusetts are asking the RMLD to sign a confidentiality agreement, which the RMLD is reviewing.

Ms. Parenteau also updated the Board on power purchases that have been done for the summer period.
