As Mr. Cameron has discussed before if ENE does go out of business, the RMLD does not secure any claim. The RMLD would simply be in line with everyone else.

Mr. Soli made a motion seconded by Mr. Ensminger that the RMLD Board of Commissioners accepts the ENE Settlement with the Chairman as authorized to sign for Reading.
