

Rate Increase 5-7% Effective July 1

At its regular board meeting on May 26, the RMLD Board of Commissioners voted 4-0 to increase rates by approximately 5-7%. This increase was originally projected at 7-9% in the fall, but as spring rolled around, RMLD had more actual data available with respect to New England projected transmission and capacity costs, along with a completed review of RMLD expenses.

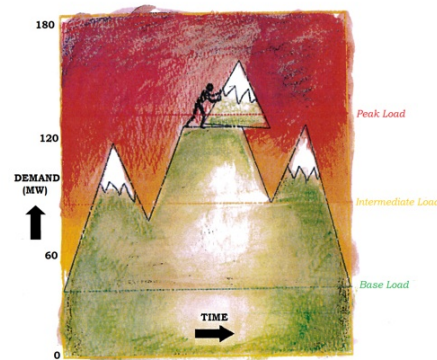
Customers using a monthly average of 500 kWh will see a \$4.81 (6.64%) monthly increase and customers using 750 kWh will see a \$7.03 (6.57%) increase. RMLD will continue to have one of the lowest electric rates in the state, along with proven reliability and safety records.

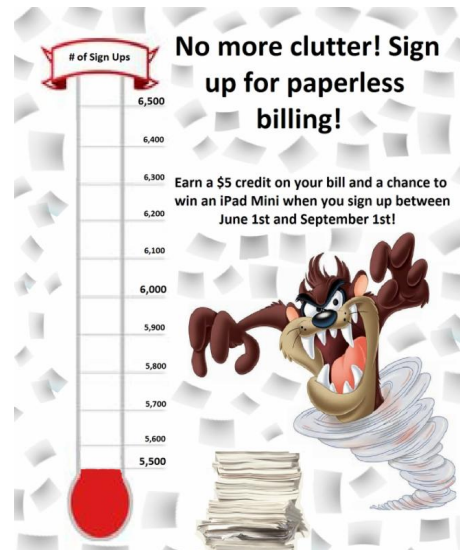

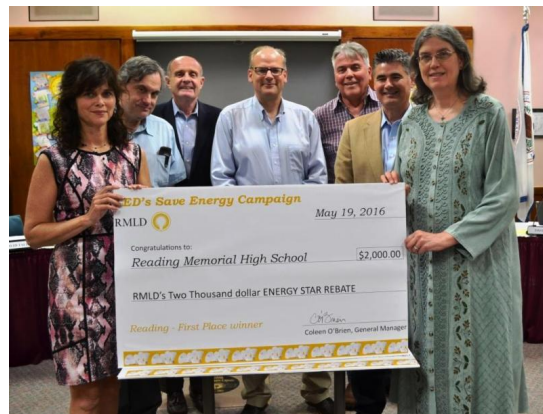
Twenty-four public schools participated in this campaign which encouraged families to help change the world, one energy savings step at a time, all while supporting their schools.

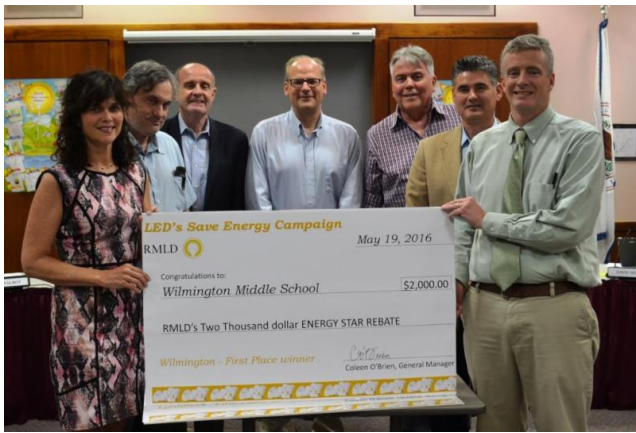
