POWER SUPPLY UPDATE

Solar Supply – Gravel Pit V



Location: East Windsor CT

Supply: 30 MW addition to under construction 120 MW facility developed by D.E. Shaw – 2025 commissioning
RMLD has existing contract for 16% of output from 50 MW Gravel Pit III (Gravel Pit IV is 70 MW for IOUs)

Volume: ~10,000 MWh/yr for RMLD (~1% RMLD total 2025 purchases; 22% of project expansion output)

Term: 25 years (2025 – 2050)

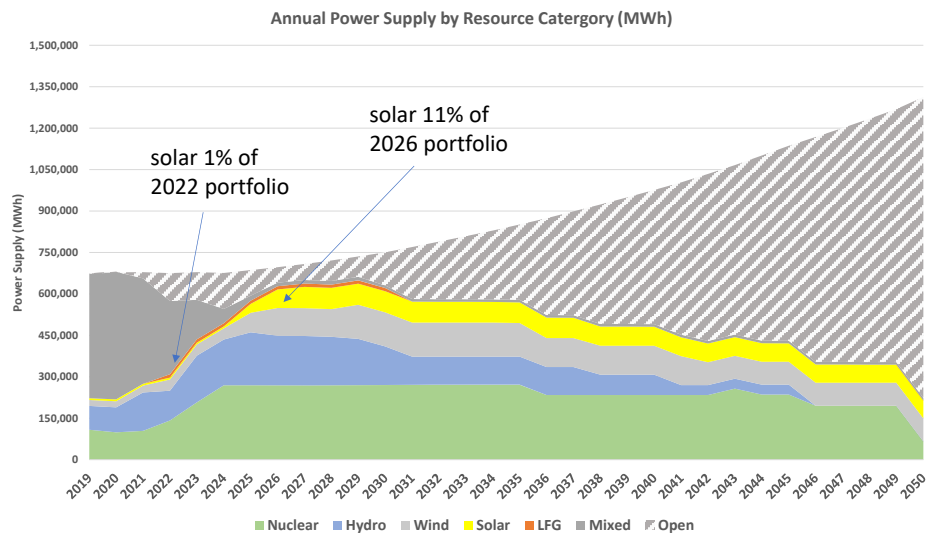
Certificates: CT Class I certificates (renewable and non-carbon)

Pricing: \$ / MWH slightly above 2025 average but fixed (no escalation) during 25 year term
